

Forest City Talent Education Bursary Program 2018-19

The purpose of the Bursary Program is to offer financial awards to help those children whose families are unable to pay the complete program fee. Applicants must be able to contribute a portion towards their fees to be eligible. This particular bursary program is for the 2018-19 season. Each year the Board determines the funding available for the Bursary Program based on donations from local citizens, NOT from government grants.

Parents must complete the 2018-19 Bursary Application, include a letter explaining the necessity for financial assistance and provide a copy of their 2017 Canada Revenue Notice of Assessment. All forms and information must be mailed to the Treasurer by the September 29, 2018 application deadline:

After the adjudication, each applicant will be informed of the decision of the committee. Decisions of this committee are final and there is no appeal. However, an unsuccessful candidate could apply in a subsequent year of membership provided there is another such bursary made available. Bursary decisions will be made by October 13, 2018 and applicants will be notified by email. Applications received after September 29th will be considered, along with all previous applications, based on the availability of bursary funds.

An external Bursary Committee, of which none of the members are FCTE Board members, FCTE contract workers, parents or relatives of current or incoming students, will review Bursary Applications and letters. Applications will be assessed based on the family's current financial need and availability of Bursary funds. This process will remain confidential and only involve the Bursary Committee and the Bookkeeper of FCTE.
